Please be advised that we have officially started our "Tonnage Verification" process.

Our objective is to make sure that the tonnage entered into the tonnage portal has been reported accurately (this is the main intent of the tonnage verification process). Sometimes kilos are entered versus pounds (as required) which of course will provide inaccurate data and skew the final results.

We appreciate your cooperation which helps us ensure that the numbers being reported are being reported correctly.

MANDATORY ATTENDANCE

As most of you are aware, PAIMA has started enforcing the "Mandatory Attendance" By-Law that was passed in 2014. Three years of notification notice was granted by the Board of Directors and official enforcement of the 2014 By-Law started in 2017.

The By-Law amendment officially states that:

PAIMA Members must be registered to attend an Annual Convention at least once every other year.

A \$500 fine will be levied for those Members that are not complying with the 2014 By-Law.
