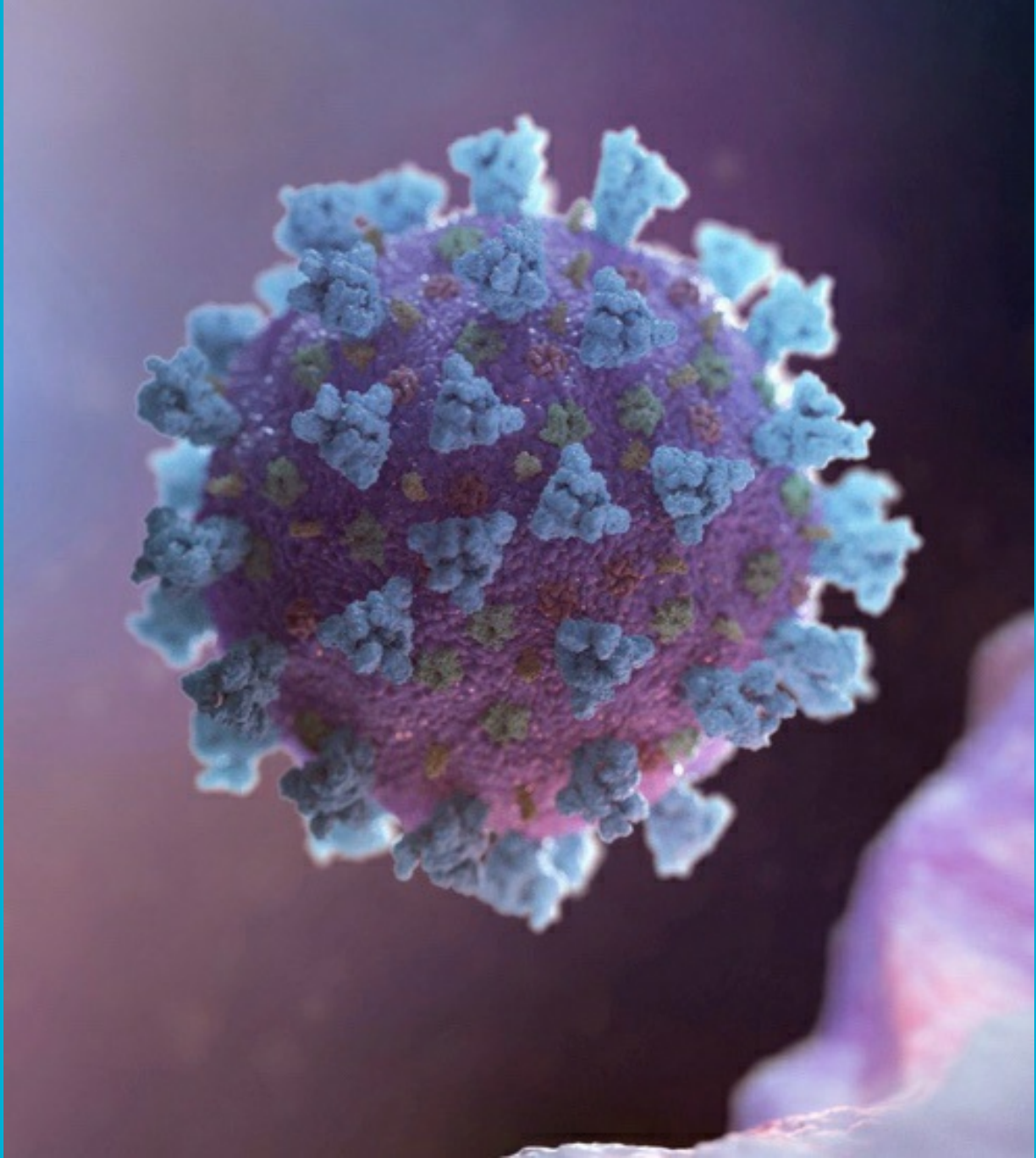

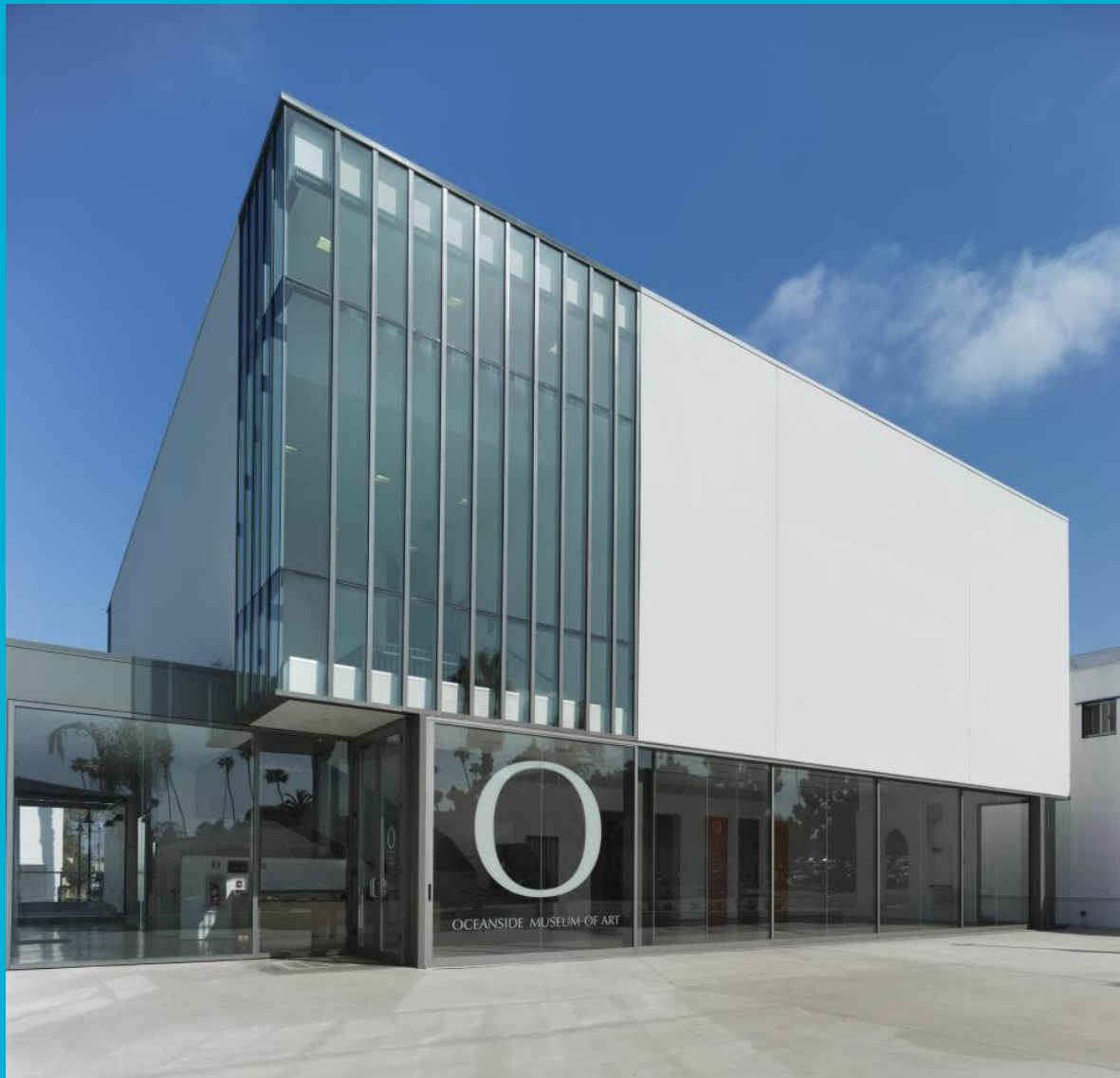
be crucial to see what further restrictions might be on the horizon. We hope to be able to hold the meeting virtually in case it has to be physically cancelled.

MANDATORY ATTENDANCE

As most of you are aware, PAIMA has started enforcing the "Mandatory Attendance" By-Law that was passed in 2014. Three years of notification notice was granted by the Board of Directors and official enforcement of the 2014 By-Law started in 2017.

The By-Law amendment officially states that:

PAIMA Members must be registered to attend an Annual Convention at least once every other year.

A \$500 fine will be levied for those Members that are not complying with the 2014 By-Law.
