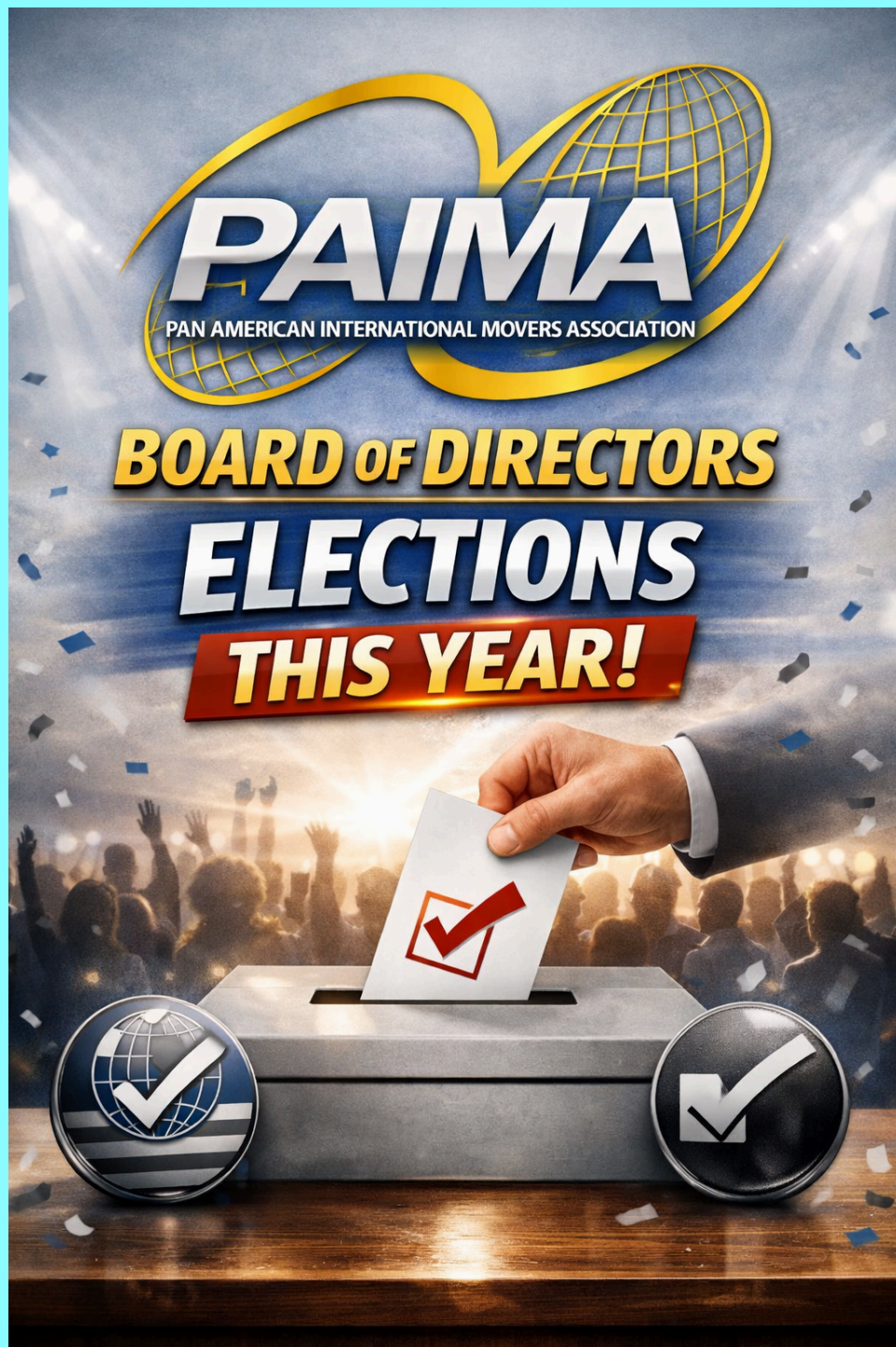

## **PAIMA Board of Directors Elections —** **October 2026**

This October, during our 42nd Annual Convention in San Diego, California, PAIMA Members will participate in the election and appointment of the President, Vice President, and five Directors, including the Immediate Past President (if he opts to stay on the Board), during our General Assembly. Following the election, the newly elected President will appoint the Secretary and Treasurer from among the elected Board of Directors.

**Nominations Now Open**

Active PAIMA Members may nominate up to three qualified individuals, each representing a different Active Member company, for election to the Board of Directors — including nominations for President and Vice President.

- Nomination Deadline: August 20, 2026  
(60 days prior to the General Assembly)

All Active Members have the right to nominate, participate, and vote as outlined in the current PAIMA By-Laws.

### Who Is Eligible?

All owners, partners, and executives from Active Member companies are eligible to be nominated. Candidates receiving at least two nominations will be notified in writing by the Executive Director and will have five days to accept or decline.

A complete list of accepted candidates will be presented at the General Assembly as part of the official agenda.

### Term of Service

The elected PAIMA Board of Directors will serve from October 2026 through October 2028.

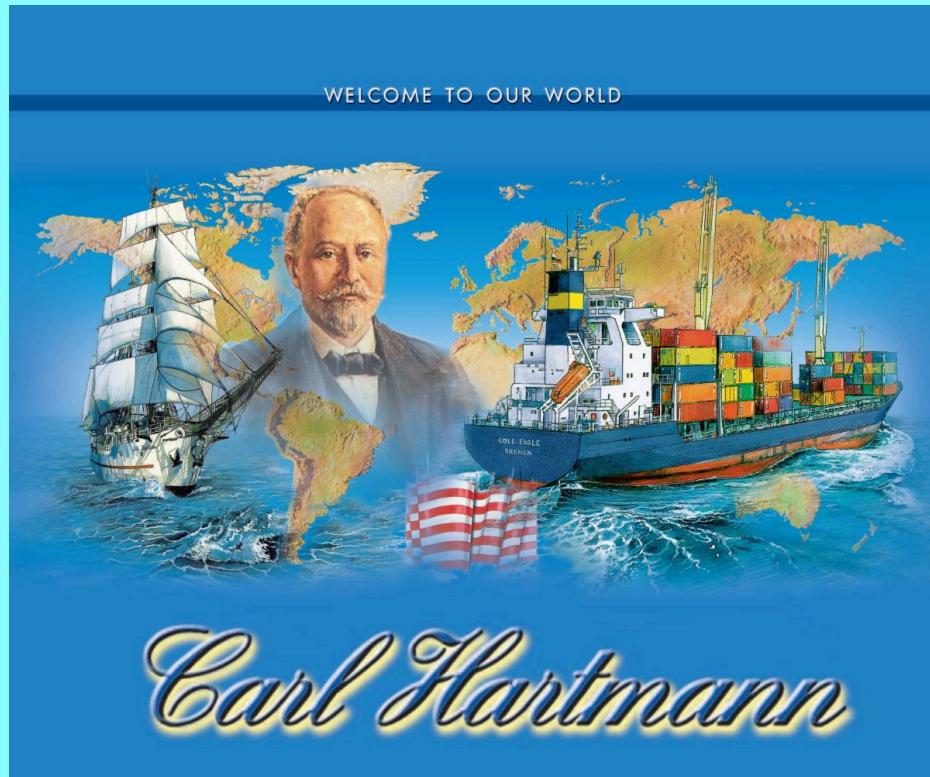
