Please make note so you are informed of the reasons behind the decision as to why Wi-Fi is not being offered in 2026.

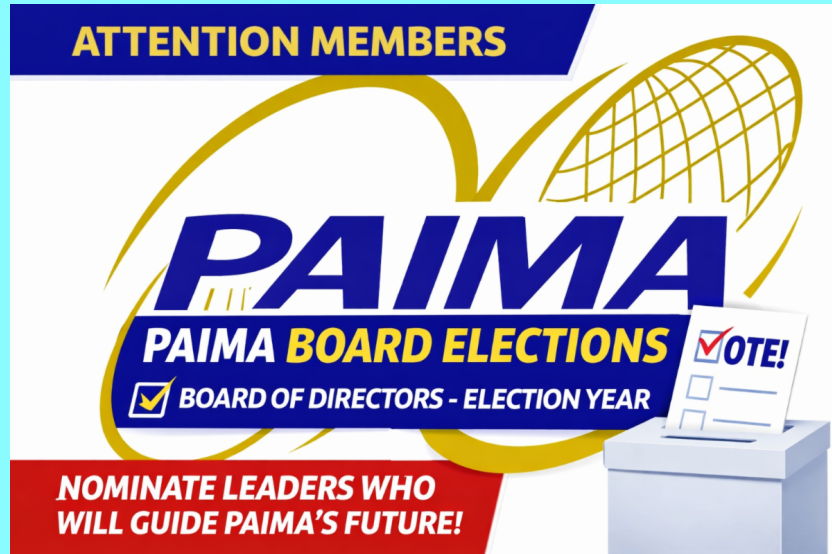

PAIMA Board of Directors Elections — Would you consider being a Board Member?

Please consider assisting shape the FUTURE of our Association by putting your name in "the hat" for this year's elections.

This coming October during our General Assembly in San Diego, PAIMA Members will participate in the election and appointment of the President, Vice President, and five Directors, including the Immediate Past President (if he opts to stay on the Board), during our General Assembly. Following the election, the newly elected President will appoint the Secretary and Treasurer from among the elected Board of Directors.

Nominations Now Open

Active PAIMA Members may nominate up to three qualified individuals, each representing a different Active Member company, for election to the Board of Directors — including nominations for President and Vice President.

- Nomination Deadline: August 20, 2026
(60 days prior to the General Assembly)

All Active Members have the right to nominate, participate, and vote as outlined in the current PAIMA By-Laws.

Who Is Eligible?

All owners, partners, and executives from Active Member companies are eligible to be nominated. Candidates receiving at least two nominations will be notified in writing by the Executive Director and will have five days to accept or decline.

A complete list of accepted candidates will be presented at the General Assembly as part of the official agenda.

Term of Service

The elected PAIMA Board of Directors will serve from October 2026 through October 2028.

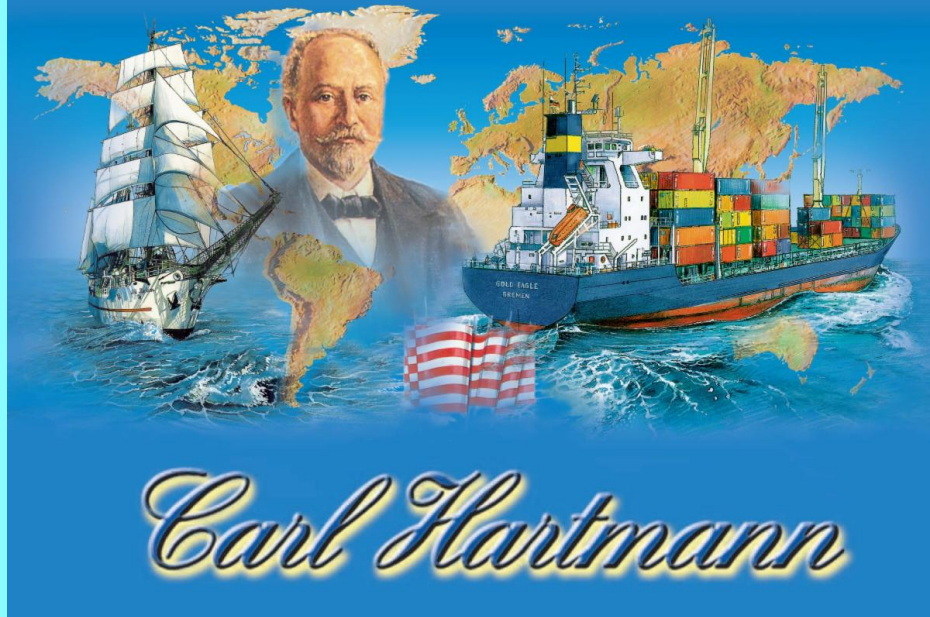

PROCESSING FEES:

After decades of PAIMA absorbing credit card and wire transfer fees, it was determined by the PAIMA Board of Directors to replicate what other associations are doing vis-a-vis credit card and wire transfer processing fees. Please be advised that moving forward, there will be a 3% convenience fee for credit card transactions and a \$75.00 wire transfer fee, for wire transfers respectively. We are happy to report that there of course are not fees for checks. Please make note and thank you for supporting the well-being of our Association.
